APPROVAL OF AGENDA

The Chair called for the approval of the agenda. The Committee approved the agenda by voice vote.

APPROVAL OF PREVIOUS MEETING MINUTES

The Chair requested a motion to approve the minutes from the previous meeting, held on September 12, 2025. The Committee approved the last meeting minutes by voice vote.

PRESIDENT'S REMARKS

Dr. Abdullah expressed his sincere appreciation and extended thanks to Dr. Willis Walter, Mr. Franklin Johnson-Norwood, and Mr. Maurice Jones for their outstanding contributions to the success of Homecoming 2025.

REPORTS AND RECOMMENDATIONS

Dr. Willis Walter, Interim Vice President for Advancement and External Engagement, delivered a concise presentation on annual donor contributions and provided an update on the Institutional Advancement comprehensive campaign. Additionally, Virginia State University has been awarded a \$2 million grant from the Thurgood Marshall College Fund to support an AI-enabled digital transformation initiative.

Project HBCU Capacity Building prioritizes both institutional and student success by:

- Expanding research infrastructure and advancing pathways toward Carnegie R1 status
- Enhancing enrollment, advising, and financial aid systems
- Driving innovation in student success, career readiness, and workforce development
- Building collaborative cohorts to share best practices across the HBCU sector

Dr. Willis Walter announced that Virginia State University has received a historic \$50 million gift—the largest single donor contribution in the University's 143-year history. Author and philanthropist MacKenzie Scott generously gifted \$50 million to VSU, marking her second transformative contribution to the institution within the past five years.

Dr. Walter gave a breakdown on Redefining the Comprehensive Campaign Goal for 2027 and what it will look like: Embrace the Momentum, Current Comprehensive Campaign Goal: \$105 Million, Establish a new attainable goal: \$125 Million, Revise and implement a strategic plan to achieve the new target, and to leverage the expertise and leadership of Institutional Advancement Co-Chairs, Victor Branch and Thomas Cosgrove.

Dr. Walter introduced two new members to his team, who are frontline fundraisers: Dr. Joscelyn Brazile Corporate/Business Relations, and Darryl Stuckey, STEAM Portfolio.

- Legacy Naming Opportunity


ADJOURNMENT
