Mr. Hill participated by electronic means as he was located in Hampton, VA. He was unable to attend due to personal reasons due to a conflict. The Board members participated by Cisco WebEx virtual meeting.

#### **INVOCATION**

Ms. Currey invited Pastor Jasmyn Graham, Director of Campus Ministries, to offer the invocation.

#### APPROVAL OF AGENDA

The Committee approved the agenda by voice vote.

#### APPROVAL OF PREVIOUS MEETING MINUTES

The Committee approved the minutes from the April 22, 2021 meeting by voice vote.

#### PRESIDENT'S REMARKS

President Abdullah shared with the Board that the administration has welcomed students back to campus and they will hear more about the preparations and status of the campus relative to Covid-19. He informed the Board about the Council of Presidents and the State Council of Higher Education for Virginia (SCHEV) meeting held on campus Monday, September 13<sup>th</sup>.

#### NOMINATIONS FOR COMMITTEE VICE CHAIR

Ms. Currey called for nominations for vice chair and informed the committee that Dr. Darden had agreed to remain in the position if the committee approved. A motion was made and properly seconded to approve Dr. Darden to continue as vice chair. The motion passed unanimously.

#### REPORTS AND RECOMMENDATIONS

Dr. Palm spoke on the Action Items for Academic Affairs. He submitted a resolution to approve the VSU Six-year plan for 2022-2028. Dr. Palm explained that the six-year plan is due on odd years. Amendments to the plan are due on even years.

Dr. Palm then gave way to Dr. Patrice Perry-Rivers, Associate Professor and Director of the Center for Entrepreneurship in the Reginald F. Lewis College of Business. Dr. Perry-Rivers spoke on the recently awarded \$453,000 grant from Growth and Opportunity aka GO VA, which is a state funded business initiative for the Minority Small Business Launch Center. The Division of Research and Economic Development supports this effort. Dr. Patrice-Rivers then explained that Entrepreneurship participation is lower in minority communities. VSU is uniquely positioned to help build inclusive entrepreneurship ecosystem in Region 4.

Dr. Palm presented information on Strategic Plan Updates, COVID-19 Updates, Enrollment Management Updates, and Six Year graduation Rates, and Strategic Plan Enrollment Rates. To monitor

where VSU is after the first year, a dashboard with data was presented representing approved benchmarks to include progression of graduation rate of 47%, enrollment projects, total degrees offered, establishment of 7 Living learning communities and VSU Online degree programs which went from 0 to 3.

Dr. Palm then spoke on VSU COVID 19 updates on behalf of Dr. Corley, Associate Vice Provost for Academic Affairs and Chair of the COVID-19 Response Team. As of September 13, 2021, the total campus positivity rate for COVID-19 is .98%. Students currently have a COVID-19 vaccination rate of 68%. Faculty/Staff currently have a COVID-19 vaccination rate of 81%. Currently 4,151 tests have been conducted resulting in 4 on campus in isolation, 3 off campus, and 26 completed isolation and have returned to class

In an effort to achieve a 90% or better COVID-19 vaccine rate, measures were put in place to include:

- 1. A \$500 and \$1000 incentive for students and faculty/staff, respectively, with documented proof of vaccine;
- 2. Student, faculty and staff testing/vaccine sites on the second floor of Gateway and Jones Dining Halls. Depending on vaccine status, all faculty, staff and students will be tested and given the option to receive the vaccine;
- 3. Communication to all unvaccinated faculty, staff and students to confirm non-compliance status;
- 4. Student communication on September 12, 2021 to vacate residence halls if non-compliant by September 18, 2021;
- 5. Cease & Desist for all registered student organizations until further notice;
- 6. Non-compliant students (commuter) will be transitioned to remote instruction;
- 7. Non-compliant faculty and staff will follow a progressive discipline strategy ultimately ending with suspension without pay and termination.

Chair Currey congratulated VSU for being safe and beating the current VA positivity rate. Dr. Palm also advised that 861+ students have been vaccinated since arriving on campus. Goal is to achieve 90% compliance. President Abdullah gave thanks to faculty and staff and for meeting students where they are. Dr. Palm gave thanks to Dr. Corley and the COVID team. Chair Currey gave further thanks to VSU family and stated absolutely remarkable and incredible of what has been accomplished.

Dr. Palm then gave the floor to Dr. Alexis Brooks-Walter, Interim Assistant Vice Provost for Student Success and Enrollment Management, who provided an update on enrollment numbers for First Time in College Freshmen, Transfers and Graduate Students. Dr. Brooks-Walter also gave updates on the Virginia College Access Network (VCAN) program, which is awarded to freshmen who live within 25 miles of VSU and meet admission requirements and are Pell eligible. Currently there are 247 First-Time Freshmen participating in the VCAN program; with the returning VCAN students, the program has over 300 students. The incoming VCAN students have a 3.13 grade point average (GPA). The program is funded by the state and provide free tuition and mandatory fees for students. About three-fourths of our VCAN scholars have opted to live on campus. In response to questions, Dr. Brooks-Walter verified that VCAN students receive tuition, room and board with 74% living on campus and 26% campus. With their welcome packet, students receive a 1-year commitment (to VSU) agreement. She indicated that there is excitement about the retention rate which is expected to be higher than last year. The retention rate will come out in October, and Dr. Brooks-Walter will report at the next board meeting.

Dr. Palm called on Dr. Tia Minnis, Vice Provost for Academic Success, Planning and Institutional Effectiveness who spoke via conference call to provide enrollment projections utilizing an "Enrollment Projection Model" that examines historical data of 1) New student Enrollment; 2) Persistence; and 3) Graduation. Dr. Minnis began with "how to move forward" and areas of improvement: Enrollment Projection Model (Predictive Analytics, Examine Historical Data); New Student Enrollment (FTIC, Persistence, Cohort enrollment Term to Term); Enrollment headcount (New Cohort-9%; Returning Cohort 91%); Methodology (New Fall and Spring Cohorts, Fall 2010 to Spring 2019, Persistence of each cohort); Future Steps (Increase Enrollment).

Dr. Minnis presented an overview of the actual enrollment numbers versus the projected enrollment numbers. She stated that adjustments were made based on the actual numbers and that the enrollment projections are based on sound logic; the University team has worked closely with SCHEV to project these numbers. The census data for fall 2021 are due in October. Chair Currey indicated that updates will be provided at the November 2021 Board meetings.

Dr. Palm then spoke on the updates of the six-year plan for 2022-2028 to be submitted to the state. New Strategic Initiatives include the following:

#### a) Financial Aid Support for Low-Income Students

To close the gap for financially challenged students – and our team is closely monitoring the latest recommendations that will be coming out of SCHEV this year.

#### b) Degree Completion and Career Enhancement Initiative

Aimed at increasing degree completion and career enhancement for students who left the university prior to completing baccalaureate degree requirements.

#### c) VSU Public Health Institute

Designed to address health disparities within underserved groups through outreach, academic endeavors, public health workforce development and research agendas in preparation of public health professionals for the future.

#### d) VSU Pipeline with Purpose

Innovative high school program designed to expand Virginia students' college pathway

#### e) VSU Advanced Manufacturing Logistics Institute

Provide resources to support workforce development and economic growth and meet the demand for future supply chain and logistic processes.

#### f) New Degree and Online Programs

Request for funding for a number of new and online programs was presented including funding to operate new instructional sites in Roanoke, Newport News and South Boston.

Dr. Palm presented a report on behalf of the Student Success & Engagement Division. He shared information about the Move-In process with 2257 students participating. He also shared information on the Charlie Hill Fellows Induction Ceremony with Keith Brown as the motivation speaker, and where Board Member and Sponsor Charlie Hill was presented with an Orange coat. In addition, the Student Government Association (SGA) Induction Ceremony was held with Judge Roger L. Gregory, VSU alumnus and Chief United States Circuit Judge of the US Court of Appeals for the Fourth Circuit, who gave the charge and oath of office for the installed SGA Officers. Dr. Palm reminded board members of

Homecoming 2021 "Back Home on the Hill". There will be a week of activities beginning October 16 and ending October 23, 2021 with the Homecoming football game.

David Bragg, Associate Vice President/Chief of Police, Campus Dept. of Police/Public Safety updated the Committee on Public Safety by providing crime statistics reports from 2018-2021 and ongoing efforts for retention of officers. With the change in the law in Virginia regarding Marijuana, all minor marijuana violations are sent to Student Conduct. There was no civil unrest on VSU campus between 2018-2021.

Mr. Hubert Harris, Chief of Staff, provided an overview of activities in Athletics on behalf of Peggy Davis, Associate Vice President for Athletics Department. Mr. Harris advised that 193 student athletes made the Honors List, 170 with GPA of 3.0 and 74 with GPA 3.5. Mr. Harris spoke on upcoming events, health and safety of players, vaccination of athletic teams, testing Programs during practice and before games. The tracking of teams that are fully vaccinated and athletes in the community.

There being no further business, the Chair adjourned the meeting. The meeting was adjourned at 11:58 a.m.

**TOPIC:** Purchase of Service Handgun by Retired Police

#### **BACKGROUND:**

Pursuant to Chapter 11.1 (§59.1-148.3) of the Code of Virginia, retired campus police officers, employed by a public institution of higher education within the Commonwealth of Virginia, are permitted to purchase the service handgun issued to the officer if the officer retires under one of the following circumstances:

- 1) officer retires after at least ten years of service,
- 2) officer retires at 70 years of age or older,
- 3) officer retires as a result of a disability incurred while on duty.

Under this code chapter, eligible officers can purchase their service handgun from the institution for \$1. If the previously issued service weapon is no longer available, VSU Police may substitute a weapon of like kind for the previously issued service handgun.

VSU Police issued a Glock 22 .40 caliber handgun with serial number GKU328 to Lieutenant Charles Baskerville as his service weapon. Glock manufactured the handgun on March 19, 2018. On July 16, 2021, Lieutenant Baskerville retired, having been employed by VSU Police from June 24, 2004, to July 16, 2021, seventeen years as a police officer within the commonwealth.

#### **AUTHORITY:**

§ 59.1-148.3 of the Code of Virginia provides the statutory authority to sell handguns to certain law enforcement officers.

#### **CONSEQUENCE OF NON-APPROVAL:**

Non-approval would result in the University not consistently applying the provisions of § 59.1-148.3 of the Code of Virginia.

### RESOLUTION OF THE VIRGINIA STATE UNIVERSITY BOARD OF VISITORS

#### APPROVAL TO SELL POLICE OFFICER FIREARM

**WHEREAS**, Section 59.1-148.3 of the *Code of Virginia* provides the statutory authority for the sale of handguns at a price of \$1 to retired law enforcement officers, who retire with at least 10 years of service, or at 70 years of age or older, or who are disabled as a result of an injury while on duty, and

WHEREAS, Lieutenant (retired) Charles Baskerville is a former campus police officer who retired from Virginia State University, with seventeen years of service in law enforcement, and

**WHEREAS**, Lieutenant (retired) Baskerville has requested to purchase the service handgun that was previously issued to him during his service as a campus police officer in the Department of Police and Public Safety at Virginia State University, under the provisions of Section 59.1-148.3 of the *Code of Virginia*, and

WHEREAS, Lieutenant (retired) Baskerville previously was issued a Glock 22 .40 caliber semiautomatic handgun with the serial number of BGKU328, and is owned by Virginia State University, and the service handgun is currently unassigned,

**NOW, THEREFORE, BE IT RESOLVED THAT,** the Board of Visitors of Virginia State University hereby approves the sale of a Glock 27 .40 caliber semiautomatic handgun with the serial number of BGKU328 to Lieutenant (retired) Charles Baskerville, for the sale price of one dollar, \$1.

The six-year rate is used for federal reporting because federal financial aid eligibility (12 semesters) is 150% of the time normally needed to complete a bachelor's degree (four years). VSU's current graduation rate is 46%.







  - In November we had 118 attendants.








