WELCOME

Rector Branch welcomed all attendees and expressed appreciation for their participation in the Board of Visitors (BOV) orientation and retreat. He provided an overview of the retreat's goals and structure, emphasizing the importance of collaboration, engagement, and strategic planning for the upcoming term. The orientation aims to familiarize new members with university governance, policies, and key initiatives, while the retreat offers an opportunity for deeper discussion and alignment on institutional priorities. Rector Branch gave a brief history of the museum where the retreat was being held. He highlighted the museum's significance in preserving and showcasing Virginia's rich cultural and historical heritage. His remarks provided context for the venue choice, underscoring its alignment with the university's mission to honor and reflect on the past while planning for the future.

INVOCATION

Rector Branch invited Dr. Tia A. Minnis to offer the invocation.

INTRODUCTIONS

FOIA

Mr. Nathan Moberly, Legal Counsel, explained that the Attorney General appoints the University Counsel and serves as legal advisor to the university and its Board of Visitors. The Board, as a collective entity, is considered the client—not any individual member. Legal Counsel provides legal guidance during closed

sessions and other official matters. Communications with Counsel are protected under the attorney-client privilege, which belongs to the institution and ensures confidentiality in legal discussions.

Mr. Moberly provided an overview of the Freedom of Information Act (FOIA), emphasizing its role in ensuring transparency in the conduct of public business. He noted that one of the most significant aspects of FOIA is its requirement for open meetings. Compliance with FOIA is essential, as failure to adhere to its provisions may result in actions taken by the board being deemed null and void.

ROUNDTABLE DISCUSSIONS

President Abdullah shared the story of the founding of Virginia State University, the fourth-oldest public institution in the state. He then shared his perspectives on the current higher education landscape—Virginia State University today.

Dr. Daniel Greenstein, Managing Director, Baker Tilly, guest speaker, was invited to provide insights on understanding and governing in the age of artificial intelligence, helping Board members and the Leadership team gain a deeper awareness of the challenges and opportunities presented by AI technologies. At Baker Tilly, Greenstein leads initiatives that enable universities and colleges to respond effectively to the rapidly evolving needs of students, their communities, and the nation, and to successfully navigate significant and mounting reputational, political, demographic, financial, and other headwinds.

The Board members had an afternoon session led by Mr. Peter McPherson, “Leadership Beyond the Gates: Supporting the President’s External Engagement”.


CLOSING REMARKS/WRAP UP
