



## 2025 Summer School Application

**Deadline to submit Summer School Application is May 31, 2025**

This request for Financial Aid applies to the Summer 2025 Sessions ONLY!

**VERY IMPORTANT:** If you have remaining eligibility from the current academic year, you may be allowed to use your financial aid to pay for summer school. For example, a student who received loans in the fall 2024/spring 2025 terms and borrowed all of their federal loan eligibility, will not have any loan funds remaining for summer school 2025; however, year-round Pell grant may be available to you based on eligibility and criteria.

**Important Facts about Summer Session:**

Please verify by checking the box next to each statement, that you have read and understand the following:

Students are required to have completed the 2024-2025 Free Application for Federal Student Aid (FAFSA) prior to the first day of summer classes, in order to receive summer financial aid.

Regardless of the amount of financial aid awarded, students are still responsible for the remainder of the summer session bill.

You may access your award after May 15, 2025, via Banner 9 Self-service. You will need to accept any aid that is offered before it can be applied to your bill/student account. Please check your VSU email frequently for updates.

If you are offered Pell Grant funds for summer 2025, please keep in mind that the semester goes toward your Pell Grant Eligibility Used. A student can use Pell Grant Funds for 12 semesters; summer counts as 1 of the 12.

You must be enrolled in 6.0 credit hours for federal loans. If a class is dropped or cancelled, it is the student's responsibility to enroll in another class for the summer session or be prepared to pay out-of-pocket.

You must be in good academic standing with SAP (Satisfactory Academic Progress), to receive financial aid during the summer sessions.

SAP will be processed at the end of summer sessions for students enrolled; this may affect a student's fall 2025 financial aid status.

If you do not qualify for financial aid, the cost is considered out of pocket, and you will need to make payment arrangements with the Student Accounts Office. *It is your responsibility to drop the class(es) to avoid charges.*

**Student Affirmation:**
